4. Terms and Conditions

1. A reservation is confirmed on receipt of your form and payment to Kentish Trader Limited, on a first come first served basis. Verbal bookings are not accepted.
2. Deposit. For long term bookings a deposit is required equivalent to the first full month of a booking. Balance due before the first day of the month of your booking.
3. All space or hut will be allocated by the market manager and his/her decision is final.
4. The site will be open every week-end and bank holiday from 10am to 5pm plus week-days in the high season.
5. All huts must be left clean and tidy. Any damage or cleaning will be charged at cost plus 20%.
6. Keys must be returned to Kentish Trader at the end of the booking.
7. No refunds will be made for cancellations or poor weather.
8. All exhibitors are responsible for clearing away all their equipment and rubbish at the end of the day.
9. All exhibitors must be set up on site with vehicles clear by 0900 for each date booked.
10. No vehicles will be allowed in the harbour area between 0900 and 1800 daily. Set up and delivery must be completed outside these times.
11. Space will only be available to local independent businesses, producers, designers and artists.
12. The organisers reserve the right to exclude any exhibitors who do not meet their entry criteria and their decision shall be final.
13. All exhibitors are required to maintain a friendly and professional appearance to all visitors and customers at all times.
14. All exhibitors are required to organise their own public liability insurance and have a certificate in place at the time of exhibiting.
15. Any exhibitors selling food or consumables must have the appropriate food hygiene and other certification available for inspection, as required by the local authority.
16. All exhibitors must complete a health and safety audit of their area and ensure that there is no fire, electrical or tripping hazards and that the safety of the public is prioritised at all times.
17. The selling of "hot food or drinks" is not permitted by Canterbury City Council.
18. Security. Kentish Trader Limited accepts no liability for damage, loss or theft to the exhibitor's property or person. Exhibitors attend at their own risk and are responsible for their own insurance and security at all times.
